Important Information

- The Queen contest will be held on <u>Saturday</u>, <u>April 29th</u>, <u>2023</u> at the Livermore Rodeo Grounds, located at 3000 Robertson Park Road in Livermore. Queen events will take place throughout the day and the coronation dinner will be at the conclusion of the contest that day.
- There is a MANDATORY CONTESTANT ORIENTATION meeting on Thursday, March 30th, 2023 7:00 p.m. at the office of the Livermore Stockmen's Rodeo Association at the Livermore Rodeo Grounds, located at 3000 Robertson Park Road in Livermore. The written test will be given at this meeting, please come prepared. ~ NO EXCEPTIONS!
- Contestants are encouraged to seek sponsorships to help share the expenses during her reign as Queen. Some possibilities may include your employer, your parent's employer, friends or relatives employers, etc. We do, however, discourage you from seeking sponsorships from those companies and organizations that already provide sponsorship *in any way* to the Livermore Stockmen's Rodeo Association.
- Contestants are REQUIRED to sell raffle tickets. This fundraiser helps to sponsor our contest and the raffle prize. The raffle prize is \$1000 cash. Tickets are \$10 each. You will receive your raffle tickets at the mandatory orientation, so line up your buyers ahead of time!
- The chosen Queen will be required to meet with the Queen Committee within seven days of being crowned to discuss and verify her prospective event calendar, which is subject to change and modification throughout her reign.
- Contestants are required to sell twenty (20) Queen Dinner Tickets to the Coronation Dinner.

Qualifications

- 1. Contestants must be 18 years of age, but not older than 24 years of age AS OF January 1, 2023.
- 2. Contestants must reside within Alameda, Contra Costa, San Joaquin, Stanislaus, Santa Clara, San Mateo, Sonoma, Tuolumne and Calaveras counties.
 - ***Residency is defined as your permanent address where you physically live the majority of the year. This is not the address where your parents or another family member resides while you are attending school.
- 3. Contestants must not be or have ever been married or divorced.
- 4. Contestants must not be pregnant or the mother of a child.
- 5. Former Miss Livermore Rodeo titleholders are ineligible to compete, unless they assumed the title.
- 6. Contestants must have been born a female.

Rules and Regulations

- 1. Prior to the contest, there is a MANDATORY ORIENTATION meeting which contestants are required to attend to be eligible to enter which entails an introduction of the Queen Committee members, other contestants, previous Queens, members of the Board, general stockholders and/or local newspapers.
- 2. This is YOUR contest; you are responsible for preparing your horse, your tack and your wardrobe throughout the contest. The Committee will provide chaperones for your assistance.
- 3. Contestants must sign the Memorandum of Understanding, the Waiver of Liability, complete the contest application, and submit the required documents mentioned in the Qualifications section to enter the contest.

- 4. Each contestant must conduct herself in a professional manner, portray high moral standards, and good sportsmanship or she will be disqualified.
- 5. If Miss Livermore Rodeo is or becomes pregnant during her reign, she will forfeit her crown and all prizes and benefits derived from the contest.
- 6. An entry fee of \$25.00, per contestant, will be required.
- 7. In the horsemanship judging, the horses and equipment will not be judged; the contestant's horsemanship ability, skill, and overall appearance (grooming and cleanliness of horse and tack) will be judged.
- 8. Contestants are to provide their own transportation to and from the contest and all promotional activities.
- 9. Contestants are required to have a suitable horse for use at the Rodeo and other related events, but it need not be the horse used in the contest.
- 10. Coaching from the sidelines is not permitted. This could be ground for complete disqualification.
- 11. Final decision in all categories will be that of the judges and/or LSRA committee members.
- 12. Pictures taken of contestants by LSRA photographers during the contest become the property of the Queen Committee and may be used for publicity. Copies may be made available to contestants.
- 13. Contestants are required to provide their own wardrobes.
- 14. Upon arrival to the contest, contestants will be under the jurisdiction and responsibility of the Queen Committee. The committee has complete charge of contestants.
- 15. Parents, friends, and relatives are welcome to attend the contest activities, and must agree to abide by all rules and regulations.
- 16. Contestants are not permitted at any time during the contest, as reigning queen or as a representative of LSRA, to drink alcoholic beverages, smoke, or use foul language in public.
- 17. All contestants must be aware of and conform to all PRCA dress codes (long sleeves, western jeans and hat).
- 18. All contestants and winner of the contest are required to dress western when representing the LSRA in any capacity.
- 19. The Miss Livermore Rodeo crown and chaps are the permanent property of the LSRA. If the contest winner chooses to keep it in her possession during her year as reigning queen, she will be responsible for returning it in the same condition that she received it.
- 20. Any problems or questions, which arise, should quickly be directed to your Queen Coordinator or member of the Queen Committee.
- 21. After the coronation, each contestant is expected to stay and behave appropriately as well as show good sportsmanship. Misconduct could cause ineligibility for future contests as well as loss of any awards received during the contest. The Queen Committee will decide this and all decisions are final.
- 22. The reigning Queen cannot hold any additional Queen title nor run for any Queen title, while representing the Livermore Rodeo Association. The Queen Committee, with majority decision, must approve any exception to this rule.

1. Written Test

The written test will be given the night of the mandatory orientation meeting and will weigh into your final overall score. The purpose of this judging is to test the contestant's knowledge of horses, tack and rodeo in general. The written test will be timed and consist of matching questions and multiple choice.

2. Oueen Dinner and Raffle Ticket Sales

Contestants are required to sell a minimum of twenty (20) Queen Dinner Tickets and one hundred (100) Raffle tickets and it will weigh into your final score. This fundraiser helps to sponsor our contest and the prizes. The raffle prize is \$1000 cash. Raffle tickets are \$10 each. You will receive your dinner and raffle tickets at the mandatory orientation, so line up your buyers ahead of time!

3. Silent Auction Raffle Item

Contestants are required to donate a live auction item. This is to support the contest, the Queen fund and to also, show your ability to gain support from local businesses. This will weigh into your final score. Contestants will be asked to announce and present their item during the live auction, at the Queen Contest Dinner. Auction items should have an estimated value of \$100 or greater. The auction items should be turned in at contest check in, in the Rodeo office. Items need to be labeled with the sponsor's name, description of the item and estimated value.


NOTE: These rules and regulations are designed for your safety and to keep the contest running properly, and in a timely and professional manner. If any grievance should arise during the contest, final decision shall be that of the Queen Committee.

Riding Pattern

NOTE: Pattern is subject to modifications depending on the arena used.

- Please note, after all contestants have completed the pattern, you may be asked to complete a modified or exercised pattern on a "borrowed" horse. Be prepared to face this challenge, but do not let it become a source of anxiety; your safety will not be compromised.
 - 1. Start at end of arena. Run down middle past center marker to a sliding stop.
 - 2. Back at least 10 feet to center. 1/4 turn left.
 - 3. Pickup right lead, large fast circle, small slow circle.
 - 4. Change leads to left, large fast circle, small slow circle.
 - 5. Change leads to right, do not close this circle.

- 6. Complete 3 1/2 spins to the right.
- 7. Continue back down side and end of arena to other side (approximately 20 feet from fence) go past center marker and come to a sliding stop.
- 8. Complete 3 1/2 spins to the left. Hesitate to complete pattern

Memorandum of Understanding

This statement represents an agreement, a Memorandum of Understanding (MOU), between the Livermore Stockmen's Rodeo Association, hereinafter referred to as "LSRA," and _______, a FY 2023 Miss Livermore Rodeo Queen contestant. The purpose of this MOU is to confirm the contestant's understanding of the expectations set forth by LSRA regarding the competition for Miss Livermore Rodeo. It discloses the expectations of Miss Livermore Rodeo and contestants vying for the title.

I understand that by competing in the "Miss Livermore Rodeo" Queen Contest, or by winning the title of Miss Livermore Rodeo, I will be representing LSRA and the city of Livermore. Furthermore, I will be responsible for promoting the sport of rodeo in its true light to the general public. I further understand that should I not be chosen as the 2023 Miss Livermore Rodeo, I may be asked to represent the Livermore Stockmen's Rodeo Association in the event that the chosen Queen is unable to appear at any of the various events. I agree that I will eagerly and enthusiastically participate in activities when invited, including riding in the Grand Entry during the upcoming Rodeo.

At all times I will strive to portray unexcelled sportsmanship and humane treatment to animals.

As LSRA's representative, I will act, speak, and dress according to the esteem my title deserves any time that I am in the public eye. I will portray a high standard of ethical and moral behavior, including on all social media sites (Facebook, Instagram, Twitter, Snapchat, etc.) and set a good example to the public.

I agree that as a contestant and/or Miss Livermore Rodeo Queen I will not hold an account, nor be active on dating applications or websites (Tender, Hinge, Bumble, etc.).

If I am chosen Miss Livermore Rodeo, I agree to the following Articles:

ARTICLE

- I. I will appear at events to promote the Livermore Rodeo and the City of Livermore throughout my entire reign, and meet the proposed agenda set forth by LSRA and this MOU. I have reviewed the proposed agenda (provided at the end of this document) and completely understand the responsibilities of Miss Livermore Rodeo. I will take the responsibility to notify my employer or professors about the proposed agenda, so I can avoid any conflicts of interest in order to attend functions. In addition, I understand that the proposed agenda is subject to change and some engagements are requested on short notice; nevertheless, I agree to make accommodations to the best of my ability.
- I. I will wear my banner, crown, buckle, and proper western attire whenever I make an appearance as Miss Livermore Rodeo, or for portrait photos for the use of promoting the Livermore Rodeo.

- III. I will comply with this MOU and keep close contact with my coordinator. It is my responsibility to notify my coordinator if: any problems arise, or if I am unable to make any appearances as scheduled. Should I be unable to make any event, I will notify her seven days in advance.
- IV. I will encourage others to participate in future contests, act as a hostess to contestants in future contests, and assist in the promotion of the contest in any way possible.
- V. I understand that all of my appearances must have LSRA's approval. While making any approved appearance, I understand that LSRA may provide a chaperone(s) to accompany me as feasible, and I will abide by the supervision of chaperone(s). I will submit receipts to my queen coordinator who will present them to the committee for approval and reimbursement by LSRA. I will know in advance if LSRA will be paying for the expenses. I understand that LSRA will pay for my expenses only, and, at no time will I expect LSRA to pay for expenses that I incur without prior approval. Receipts must be submitted within thirty days of the event.
- VI. I understand that I would have to forfeit all prizes (for example, saddle, buckle, banners, trophies, etc.), if I act in a manner that does not adhere to this MOU. If there are negative reports on my conduct, my coordinator will discuss the matter with me. If there is no resolution to the problem, LSRA will demand that I relinquish my title along with prizes.
- VII. I understand that if I do not fulfill my full term of Livermore Rodeo Queen, nor meet the expectations set forth in the Rules and Regulations or this MOU, I would have to forfeit all prizes (saddle, buckle, banners, trophies, etc.).
- VIII. I completely understand that the Livermore Rodeo Queen Contest is a competition that recognizes a number of attributes: horsemanship, appearance, personality, public speaking, and horse husbandry knowledge. During the contest, I will exhibit the utmost sportsmanship and conduct myself in a professional manner.
- IX. I acknowledge that I have read, understand and agree to abide by the Rules and Regulations as set forth by the Miss Livermore Rodeo Queen Contest Committee.
